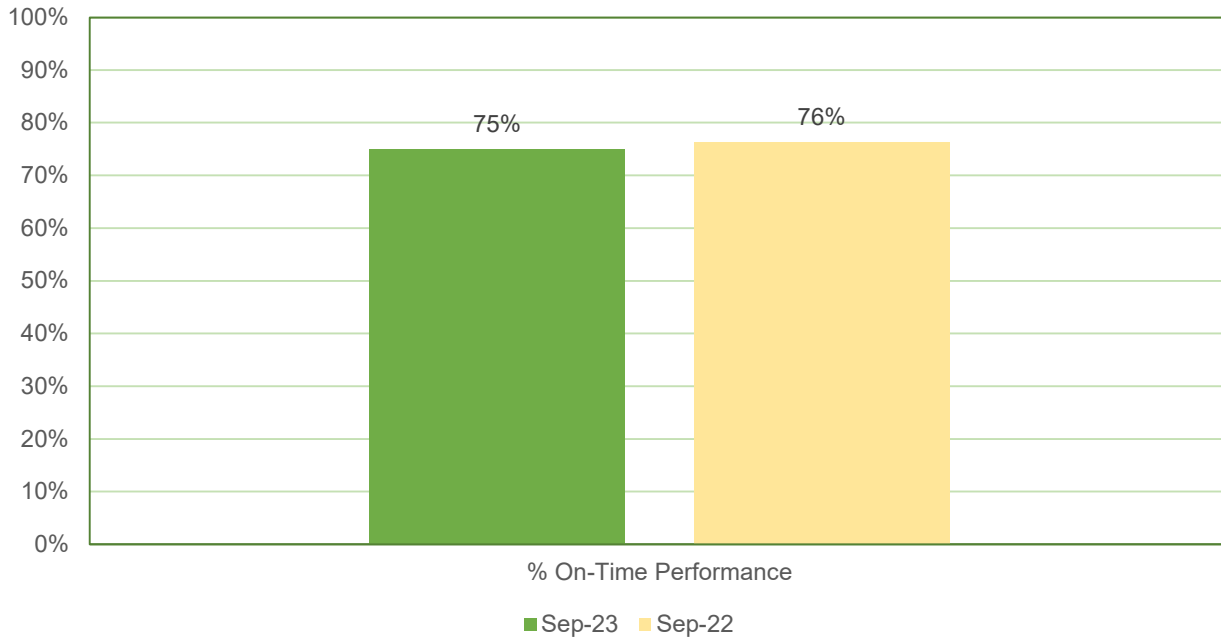

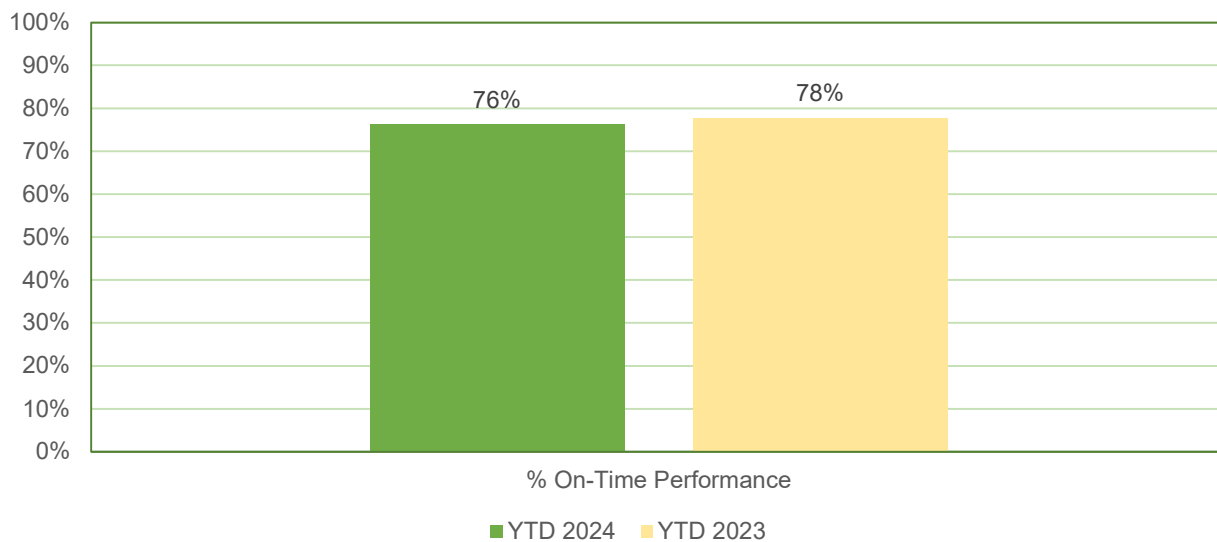

Year To Date (September)

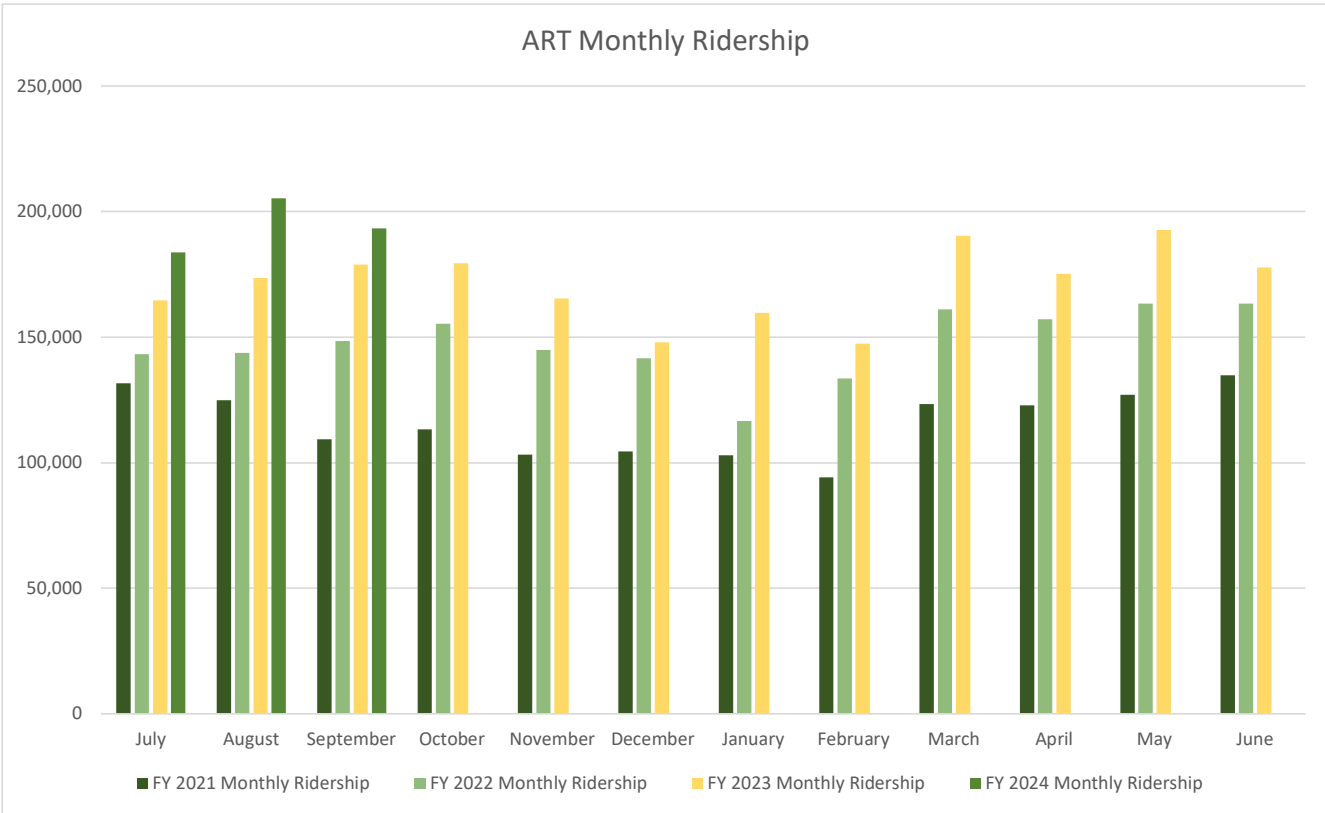
